Dear Rainbow Family friends of Water Singing On The Rocks

I don't know you all, but I ask anyway that if you are a friend of WSOTR, to forward this on to other friends that you know of, and ask them to do the same, including using snail mail where necessary, until everyone who knows Water has the story. - timbear

I have some terrible news. WSOTR is in jail in VA. It seems he was delivering a little smoke to his friend of 30 years, who handed him over to the local drug task force in an attempt to save himself. It didn't stop there. The VA task force called the East Texas task force, who got a warrant and later that night, Dec 17th, raided his home in TX. Alisa and his two daughters were home alone when the nazis burst in. Alisa was arrested, but is out on bail.

Alisa is not very good at asking for help, but I am not bashful a bit, so I got the job. After the police got through wrecking her house, she and I have spent weeks organizing her records and building a monthly budget. Most of it is based on actual records of expenses. Where we had to estimate, we were conservative. Please keep in mind that it costs a lot to raise two girls, especially when you have no health insurance. They are growing so fast! Alisa has no real income, and if she were to go to work at some menial job, she would have to put the girls in day care. That cost is more than her prospects for earning. So, her friends feel strongly that she should not attempt to work outside the home until Vauna Lee (age 2) is in school. Until then, we will all have to pull together to support Alisa and her beautiful children. Alisa is doing her part too. She is cutting back on Sarafina's activities, applying for food stamps, and investigating the sale of jewelry via the internet.

The Budget- (I hope you're sitting down) is \$1780.00 each month.

Each of you know how much you can help. What I am asking of you is to commit an amount that you can afford to send each month, then begin sending your contributions immediately. You may send your help a variety of ways.

Alan needs funds to spend in the canteen and to pay the expenses of incarceration. He has to buy everything he needs from the canteen, including clothing, paper, stamps, etc. He has to pay \$1.00/day, plus \$10.00 to see a nurse, plus \$10.00 to see a doctor. If you would like to contribute to him, you may send a postal money order (and nothing else) to the address above. Also, it must be completely filled out. Letters to Alan must be on plain paper, written in black or blue ink, or pencil, or colored pencil. No drawings please, except in pencil on plain paper. Photos must be less than 6"x6", no Polaroids, no nudes. No blank paper, envelopes, stamps, nothing glued, no books, no magazines. Remember that the jail reads everything coming in.
