The purpose of this writing is to inform you that the 'Group Use' permit engaged by the 'Divine Composting and Composing Church of the Sacred Rainbow Imagination' ("Holder", no. 5765-01) is hereby declared a nullity.

Due to material breaches of the terms and conditions of the special use authorization, and the failure of the Forest Service to abide by the spirit and intent of the agreement, the Holder is released from any duties and obligations attendant to the permit.

Specifically, the Forest Service failed to honor certain terms and preconditions to the authorization, including the failure to maintain unobstructed public access to the site due to presence of roadblocks and checkpoints. Moreover, the disruptive presence of visible firearms in the Cathedral violated the spirit of the agreement and conflicted with fundamental Church precepts. Furthermore, the mutual agreement that the Operating Plan would be an evolving and organic instrument cooperatively conceived was violated by the exclusion of the Holder from certain basic operating decisions. (See attached Affidavit).

This writing further serves as a timely refusal for cause pursuant to the provisions of the Uniform Commercial Code. Any and all obligations incurred by the Holder of the special use authorization are discharged.
