## re: Proceedings on CFR Petition per 5 U.S.C. §553(e)

Ms. Graves & FOIA Staff:

This is a Request under the Freedom of Information Act, 5 U.S.C. §552, concerning our <u>Petition to Amend a National Forest Regulation</u>, as resubmitted to the Under Secretary for Natural Resources and Environment (NRE) by <u>letter dated 12 September 2021</u>, and related proceedings in conjunction with the Office of the USFS Chief. Please provide the following documents:

- 1) NRE & USFS staff notifications & memos upon and after receipt of the Petition package via certified mail and in digital format via email in mid-September 2021.
- 2) Meeting requests received and related correspondence on the scope and scheduling of virtual meetings with stakeholders; agency communications and directives delegating such meetings and the preliminary review of the proposed rulemaking to selected USDA-FS staff.
- 3) Reports on this matter from the designated USFS staff under the direction of Deputy Chief Christopher French, and recommendations received at NRE after the March 1 meeting concerning the assessment and disposition of this proposal.
- 4) Deliberations in the Office of the Secretary and NRE on the legal & policy substance of the Petition, decision memos on the prospective review & rulemaking process, and the requisite "Workplan" pursuant to Departmental Regulation 1512-1, §3d.
